Dear Comrades.

NATIONAL EXECUTIVE COMMITTEE MEETING ON 23.08.2025 AND CENTRAL COMMITTEE MEETING ON 24.08.2025 HELD AT PONDICHERRY

A meeting of the National Executive Committee, under the Presidentship of Com. R. Balaji, President of our organization, was held on 23rd August 2025 at "Maple Hall, The Sunway Manor, Pondicherry". Com. Milind Nadkarni, Sr. Vice President, Com. S.C. Balaji, Sr. Vice President, Com. Pankaj Kaushik, Sr. Vice President, Com. L. Chandrasekhar, General Secretary, Com. Raju Kumar Singh, Vice President, Com. S. Akhil, Vice President, Com. Anzil K.N., Vice President, Com. M. Baskar, Vice President, and Com. Karuna Nidhan, Vice President, were present on the dais.

Com. R. Balaji, President, NCBE, apprised the members about the developments at industry level in connection with conciliation meeting with CLC on account of postponement of 2-day strike. He emphasized the urgent need to fill the UFBU convenorship.

Com. L. Chandrasekhar, General Secretary, NCBE highlighted the decisions of the last National Executive Committee meeting held in New Delhi. The Executive Committee unanimously approved the affiliation to Karnataka Vikas Grameena Bank.

The General Secretary stressed the need to strengthen NCBE and all the affiliates presented innovative thoughts to further strengthen NCBE.

Further General Secretary briefed the Committee about the industry level developments like,

- Payment of Dearness Relief Change of Base Year (2016=100) series to Pensioners
- Clarification on classification of Branches in Special Economic Zones/Export Promotion Zones for Project Area Compensatory Allowance
- Enhancement of Gratuity Ceiling to Rs. 25 lakhs

- Opposition to engagement of Apprentices
- Status of various Residual Issues
- Provision for exercising choice of Pension Fund Manager and Investment Pattern in NPS
- Appeal against raising Capital through Initial Public Offer by RRBs
- Recruitment of Customer Service Associates in Bank of India (2025-26 Batch)

A booklet on Artificial Intelligence (AI) was released to create awareness. The General Secretary explained the growing penetration of AI in the banking industry, deliberated on its impact, and urged members to remain vigilant.

Com. R. Balaji, President, expressed confidence that a special rebate on medical insurance premium payments and the implementation of the Leave Bank scheme both currently under negotiation by the UFBU would be achieved.

Com. Milind Nadkarni, Sr. Vice President appreciated the initiatives of NCBE and urged that all State Conferences be completed at the earliest.

Com. S.C. Balaji, Sr. Vice President, insisted the need of adequate recruitment in all cadres.

Com. Pankaj Kaushik, Sr. Vice President, briefed the house on the importance of unity.

Central Committee Meeting

The Central Committee of the National Confederation of Bank Employees (NCBE) was held on 24th August 2025 at "Maple Hall, The Sunway Manor, Pondicherry" under the Presidentship of Com. R. Balaji, along with Sr. Vice Presidents, Com. L. Chandrasekhar, General Secretary, and other Vice Presidents.

Com. R. Balaji, President, briefed the house on the acute shortage of award staff, pointing out that the ongoing recruitment in various banks is grossly inadequate. He further highlighted that while supervisory staff in SBI are granted special pay, NCBE will take up the case to secure the same benefit for award staff across the entire banking industry.

Com. L. Chandrasekhar, General Secretary, greeted the house and briefed about the latest developments at the industry level. He appealed the Central Committee to carry out more grassroot activities to strengthen NCBE.

General Secretary informed that the 5 Day Banking issue is currently under conciliation with the CLC (C) and DFS and updated the house on conciliation proceedings conducted by CLC with DFS, which covered issues such as Outsourcing, Enhancement of Gratuity, PLI, Recruitments, Pension Updation, Appointment of Workman Directors, etc. On recommendations of Com. Anzil KN, Vice President, South Indian Bank, the house unanimously resolved demanding the extension of PLI scheme to Private Sector Banks.

He also informed the house about the creation of the NCBE WhatsApp Channel and requested all to join it to stay updated on the latest developments. He further announced that the NCBE Digital Magazine will be titled "**NCBE VOICE**", which was unanimously approved by the Central Committee.
