Latest Developments

A significant meeting of the Presidents, General Secretaries of our Units, and NCBISU representatives in NCBE was held on **Sunday, 31st August 2025** at the **BOISA (Punjab) Central Office, Jalandhar**, under the Presidentship of **Com. K.K. Khosla, President of our Federation NCBISU**.

The house deliberated upon the most pressing issues confronting our staff and organization, namely:

- * **Immediate recruitment of adequate staff to reduce workload.**
(As advised earlier bank released the list of 1552 candidates for recruitment on 14-08-2025 & now document verification is going on at Zonal level.
- * **Absorption of casual labour to ensure dignity and job security.**
- * **Implementation of request transfers without delay.**
- * **Filling up of all vacant special pay duty posts.**
- * **Strict resistance to violations of bipartite settlements.**
- * **Mobilization of membership to further strengthen our mighty UNION.**

The house was informed that **Interzone request transfers** are linked with recruitment. This issue has been consistently raised by our Federation through NCBE, and it is very likely that orders will soon be released, similar to the recruitment list. We have also urged the management to issue all pending request transfer orders of eligible applicants strictly as per the **“TRANSFER POLICY ON INTERZONE REQUEST TRANSFERS”** circulated by Head Office (Ref: BC.91/59, dated 02-07-1997), without exceptions.


It was further emphasized that a **common relieving date** must be ensured for all transferees to avoid unnecessary delays under one pretext or another.

Friends, these are not just demands—these are our **rights**. We stand **united and determined** to achieve them. The meeting resolved to **intensify organizational efforts, expose anti-staff policies, and ensure that justice prevails for every employee.**

We appeal all staff members to **Beware of false propaganda by the Sole Bargaining Agents.**

Let us rise with **greater strength, solidarity, & conviction**. Together, we shall **protect our rights and secure our future.**
