TO ALL AFFILIATES & MEMBERS:

Dear Comrades,

RECRUITMENT OF CUSTOMER SERVICE ASSOCIATES

Our affiliates are hereby informed that the National Confederation of Bank Employees (NCBE) has consistently underscored the urgent need for adequate recruitment across the banking sector. This critical issue has been persistently pursued with the Department of Financial Services (DFS), the Ministry of Labour & Employment, and the Indian Banks' Association (IBA), under the banner of UFBU and remains an ongoing focus of our efforts. At present, the matter is under active consideration through conciliation proceedings led by the Chief Labour Commissioner (c), following the UFBU's strike call on 24th and 25th March 2025.

During the meetings convened by the Chief Labour Commissioner on 21.03.2025, 29.04.2025, and 17.06.2025, both the IBA and representatives of various banks reported that steps are being taken to strengthen clerical staffing. Additionally, they noted that discussions with the unions on the recruitment of subordinate staff will continue.

As a result of the sustained advocacy by NCBE under the banner of UFBU, IBPS issued a notification on July 31, 2025, announcing that banks have declared a total of 10,277 clerical vacancies for the financial year 2026-27.
