<u>12<sup>TH</sup> BPS - MOU SIGNED BETWEEN UFBU & IBA</u> WE APPEND BELOW THE SALIENT FEATURES OF MOU SIGNED ON 07-12-2023 and UNDERSTAING REACHED ON CERTAIN ISSUES.

- 1. The Proposed wage revision will be effective from 1<sup>st</sup> November, 2022.
- 2. The Settlement would be for a period of 5 years upto Oct.2027.
- 3. This Wage revision settlement would cost Rs. 12,449 crore per annum, i.e. an increase of 17% over the cost of payslip components of the wage bill pertaining to the financial year 2021-22.
- 4. Revised Payscales would be worked out by merging DA upto 8088 points @ DA 30.38% I.E. 434 SLAB plus 3% loading there on.

- 7. Adequate Increase In Halting Allowance & Lodging expenses. \*Agreed as under: 1500 /1350/1000clerk 1100/900/600 Sub Staff Hotel room rent ceiling 3000/2500/2000clerk 1500/1250/1000 Sub Staff
- 8. When Hotel room rent receipt is produced for reimbursement, 50% of Diem is to be paid towards boarding/food expenses. Agreed at 35% of Diem
- 9. Provision for separate rates of diem and travel expenses to employees sent on official duty/deputation within the station and within the urban applomeration based on distance criteria At centers of 12 lacs and above, Diem will be paid if the distance between the original branch and deputed branch is 20km and above.

- 10. Introduction of Education Allowance Agreed for 2 children upto graduation –amount subject to final costing
- 11. Introduction of Learning Allowance Agreed Amount to be decided
- 12. Revision in Deputation Allowance Agreed Amount to be decided
- 13. Upward revision of cycle allowance, Cycle/Scooty allowance- 250 pm
- 14. Washing allowance. Washing allowance – 300 pm

15. Split Duty Allowance Split Duty Allowance – 250 pm

16. Reimbursement for periodical eye checkup for employees due to constant Exposure to computer. Agreed in principle–amount/details to be worked out

17. While we demanded **updation of PENSION** for all the pensioners, after discussion, IBA came forward and agreed that as a onetime measure, grant of additional monthly ex-gratia pension for all pensioners/family pensioners from **01-11-1986** would be considered. Details will be worked out during further discussions.

18. Regarding introduction of 5 Day Banking, while IBA has already recommended the same to the Government, IBA agreed to pursue the matter with the Government so that the same is cleared without further delay. We have emphasized and urged that in any case it should be introduced before our final settlement.

**19**. All other issues would be discussed further and final settlement would be arrived at within the next 6 months.
